# **Course Catalog Update**

**MOTION**: Moved by Ryan Blessing, seconded by Dan Duffiney, that the Northport Board of Education approve the course catalog updates, as presented."

DISCUSSION: The only changes were highlighted in yellow in packet. Two big changes- we are listing out each subject for elementary so that our teachers can grade in OTUS and have it also exist in PowerSchool, auditor requires it listed in course catalog. Adding middle school Spanish exploratory as an elective that focuses on culture and basic vocabulary prior to reaching Spanish 1. We are also adding a work-study course, as required by the state, due to a student requesting it.
